ARTICLES OF INCORPORATION OF THE

The undersigned, Karl A. Moellmer, Herbert Posner, Richard A. Miles and Donald G. De Jong, for the purpose of forming a corporation under the non-profit laws, RCW24.03, of the State of Washington, state:

I

The name of the corporation shall be the Western Washington Repeater Association.

II

The term of existance shall be perpetual

III

The purpose for which the corporation is organized are to further the cause of amateur radio and to provide reliable methods of communications for service to the community in the event of an emergency. The association also will provide communications when requested by the local county sheriff's office and other organizations.

IV

The address of the initial registered office of the corporation shall be: 1315 Elizabeth Ave., Bremerton, Wa. 98310. The Registered Agent shall be Donald G. De Jong.

V

The number of directors constituting the initial Board of Directors shall be four. The names and addresses of the persons who are to serve as the initial directors are as follows:
